
Do you believe short term rentals have a positive affect or a negative affect on Pensacola Beach?





Do you have a positive or negative opinion about event homes on Pensacola Beach?






Do you think the Escambia County Sheriff's Department is doing a good job on Pensacola Beach?










How would you rank Commissioner Bender's performance as an elected official?




How would you rank SRIA's performance as a dependent governing board?






How would you rank State Representative Alex Andrade's performance as a state legislator?




How would you rank State Senator Doug Broxson's performance as a state senator?






How would you rank US Representative Matt Gaetz's performance in Congress?
